Note: Report of the Local Enquiry Committee for the period of 2019-20 is enclosed. The affiliation is renewed to the college as per the intake fixed by the Syndicate and LIC. The college shall submit the action taken report indicating the measures taken to improve the lapses and short comings as noted in the report within 15 days from the date of this notification. Failing to comply with this, the application for renewal will not be considered.

CONDITIONS:

- 1) The college shall strictly observe the conditions noted as per the LIC committee report.
- 2) University will not consider and approve any excess admission (more than the fixed intake) admissions are made beyond the sanctioned intake for the course.
- 3) The college shall not enhance the students strength of section for any course/s without prior permission of the university.
- 4) While making admission for the courses, the college shall strictly follow the reservation norms as informed by the Govt from time to time.
- 5) The college shall strictly follow the rules/regulations/ statutory guidelines and such other notifications with respect to students, Teaching & Non-Teaching staff.
- 6) The admission for the sanctioned courses shall be made as per the affiliation notification issued for the courses and within the sanctioned intake only. The college shall not violate any eligibility rules & regulations while making the admission. While making admission for the sanctioned PG courses the approved intake and fees for the course shall be followed. College shall not charge extra fee for the students. The college is eligible to make admission to 50% of sanctioned intake by observing the eligibility criteria and approved fees for the course by the University. For govt. Colleges, University will make the admission for all the sanctioned seats.
- 7) As per the Honourable Supreme Court Judgment in respect of Vaishak and Govt of Rajasthan, if causing any atrocity, sexual harassment at the college & office or in a ny working place by any person is an offence. If any person/student is involved in such activities, the college can remove the people from job or debar the students from the college. To stop such atrocities the college shall establish the compliant cell as per the order of Supreme Court and also UGC.

- a) The conege shall improve the education courses for development of the students. The conege management shall treat the Students, Faculty, Principal and other staff with utmost respect.
- 9) The college shall not retain the marks cards and such other documents of students with them beyond 6 months. The marks cards and other documents submitted by the student for admission approval shall be returned soon after the approval of admission with intimation to the students.
- 10) If the student has submitted the request for T.C (Transfer Certificate) the college shall issue the T.C. without any difficulty. While issuing T.C. the college shall collect only the tuition fees for the incomplete period. There is no provision for collecting any extra/ additional fees as per rule.
- 11) The college shall not collect any capitation fees.
- 12) The official correspondence shall be in Kannada only.
- 13) The college shall submit the application for renewal of affiliation for the year 2020-21 without fail.
- 14) The colleges if completed five years shall obtain recognition of NACC accreditation.
- 15) The Principal shall submit the eligible list of teachers to the Chairman BOE for valuation work without fail. Failing to comply with this condition the affiliation for the college will be cancelled.
- 16) The balance amount if any in respect of affiliation is due with the college shall be paid to the university account, (through online) otherwise the university will withhold all the academic and other activities of the college.
